  - The user is navigated to the CSD Home Page
- 2. Click on Register on the menu bar on the CSD Home Page
- 3. Enter your:

  - Name
  - Surname
  - Cellphone number
- 4. Select an identification type in the identification type dropdown
- 5. Enter identification number

If a foreign passport number or foreign ID number is entered then a work permit number must also be entered

6. Enter a password

A password must contain a minimum of 8 characters and include a capital letter, a lower case letter, a number

and a special character

- 7. Confirm password
- 8. Select and complete 3 security questions
- 9. Check the I am not a robot Captcha
- 10. Check the I accept the terms and conditions
  - 11. Click on the **Register** button
    - The following message will be displayed: 'Thank you for registering. An account activation e-mail has been
    - Sent to you'. In order for you to use your account, you will have to click the link in the e-mail to activate your account.
