ii.	Supplier's Tax is Non- Compliant	SARS Requires all companies to file their returns twice a year (by the 28 <sup>th</sup> of February and by the 31 <sup>st</sup> of August) it is the responsibility of the supplier to make sure that all their returns are up to date to avoid Non-Compliance.
iii.	Supplier's Tax is Non- Compliant	B-BBEE expires after a year from date of issue. There are 3 types of BEEs you can get: B-BBEE certificate from SANAS accredited agency, B-BBEE certificate from CIPC, Sworn Affidavit from Commissioner of Oath
iv.	Supplier's Tax is Non- Compliant	Supplier should ensure that all the SBD documents are signed and declare when necessary and make sure they complete the job as per the order.
